"Journal of Tax Practice & Procedure." Ms. Hill has testified before both the Senate Finance Committee and House Ways & Means Committee on tax issues, including tax law complexity and the Alternative Minimum Tax (AMT). In March 2005, Claudia was invited to testify about the individual AMT at the President's Tax Reform Panel. She is often called upon by the media for comment about tax issues. She served on the 1987 Commissioner's Advisory Group to the National Office of the I.R.S. Ms. Hill is owner and principal of Tax Mam, Inc., and TMI Tax Services Group, Inc. in Cupertino, CA.
